Introduction

The event is a conference-webinar involving online and on-the-spot participation of national and international experts. For this reason, we are all kindly invited to speak in English. - Promote a constructive debate on a crucial achievement for European citizens and patients, the Directive on patients' rights in cross-border healthcare, as well as on the current state of its implementation throughout Europe. The fact that the Directive title contains the words "patients' rights" demonstrates that this normative highlights the relation between citizens/patients and healthcare systems.
- Discuss concrete actions in order to facilitate access to better and safer care for patients in the EU.
