Dastoli's career includes being the Personal Assistant of Altiero Spinelli in the Italian Parliament (1977-1979) and in the EP (1977-1986), being the Secretary General of the European Movement International (1995-2002), being the Head of the EC Representation in Italy (2003-2009), and being the President of the Italian Council of European Movement (from 2010) and member of the Board of the European Movement International. Currently he is the President of the Associazione Italiana della Comunicazione Pubblica e Istituzionale (2018 - current) and a Professor of renown in International Law at the University for Foreign Students "Dante Alighieri" (2016-2020). Dastoli also holds membership positions in the UEF Federal Committee, the International board of CIFE, and the Steering Committee of the European Civic Forum, as well as being the Honorary President of the Centre for the Rights of Citizens and People (University of Sassari) and the Commendatore al Merito della Repubblica.



Anna Lisa Mandorino

As the Seputy Secretary-General of Cittadinanzattiva since January 2009, Mandorino is responsible for the Participation and Civic Activism area, directing the national headquarters of Cittadinanzattiva and coordinating the interaction with hundreds of territories of the organization present throughout Italy.
