

## European Patients' Rights Day MAKE IT OFFICIAL!!! Add your voice to those calling for the European Patients' Rights Day

Dear Commissioner Dalli,

All the associations below mentioned\* are writing to draw your attention to the Institutionalisation of the European Patients' Rights Day.

The recognition of Patients' Rights across the Union is an increasing demand from European citizens, and we all know that the reinforcement of these rights will become effective only with the cooperation and commitment of all stakeholders in each EU country.

Thus it is essential to increase awareness regarding the importance of patients' rights and everyone's responsibilities in guaranteeing their respect. We believe that celebrating a European Patients' Rights Day every year in all EU Member States would greatly contribute to this goal. This would be an excellent opportunity and an occasion to inform, discuss and make commitments to improve patients' rights in Europe and in each member state.

For this reason ACN together with a large number of patients and civil society organisations across the European Union, have taken the initiative to organize for the last five consecutive years the European Patients' Rights Day with events in more than a 100 European Cities in 26 European countries.

A fundamental innovative aspect is that the events are driven by citizens and patient's organizations providing a civic perspective and recognizing citizens not only as "users or consumers" of health services or "patients" with a specific diseases, but rather as an essential stakeholder concerned with the sustainability, safety and quality of healthcare.

Two Resolutions<sup>1</sup> from the European Parliament have called for the adoption of a European Charter of Patients' Rights on the basis of existing charters in the Member States. In addition, the EESC approved an Opinion on Patient's rights (September 26, 2007) calling on the European Commission to establish a European Patients' Rights Day, as we asked during the first European Patients' Right Day.
